Where: + represents the outward international dialling code. This varies between countries. Please check locally.

(a) is the country code. This remains the same for each country regardless of the country from which the caller is dialling.

(b) is the city code. The zero or other number shown in the brackets, i.e. (0), is normally omitted when dialling from outside the country. However, if dialling within the country, it may be required.

(c) is the telephone number. This is typically the only part of the number, which is required when dialling locally.
